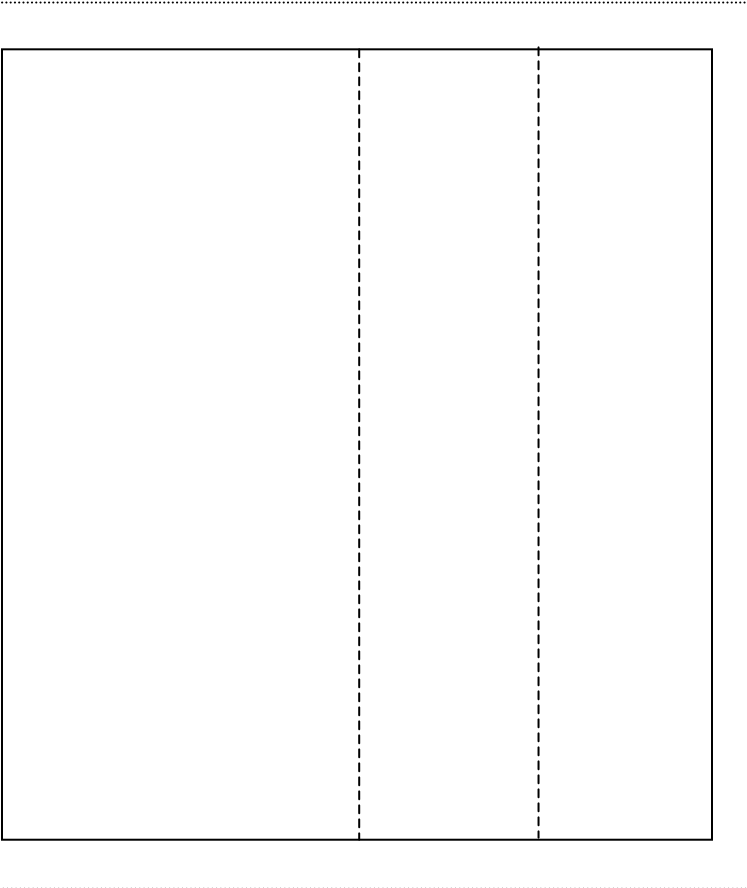

The City of Bridgeport requires a Floor Plan for all new construction projects and must be drawn to scale. Floor plans should be attached on a separate sheet and include all of the following:

1. All floors, including basement
2. All rooms, current and proposed, use of each room and dimensions
3. Location of structural elements and openings
4. Doors and windows (location, size, swing, and hardware)
5. Fire assemblies and separations.
6. Identify new/existing walls, call out construction of walls
7. Interior finish
